Retiring Board Members

Sarah Holway | Sarah joined the Board in 2017, jumping in right away as chair of the Education and Collections Committee. At the beginning of Sarah’s second term in 2020 she served as co-chair of the Phillips Farm Committee. Shortly thereafter Sarah became chair of the Development Committee and has continued to serve in that capacity through the remainder of her term. Sarah was instrumental in launching the Feast With Friends series. Sarah continually leverages her network, her Waterford property, and her Corner Store business to support the Foundation and its preservation and education mission. We will miss Sarah’s input on the Board of Directors, but we look forward to her continuing support of the Feast With Friends series and other Foundation activities.



J. Forest Hayes | Since joining the Board in April 2020, Forest has served on the Foundation’s Land Use Subcommittee, bringing his expertise and knowledge from serving as chair of Loudoun’s Planning Commission to bear regarding the use of Waterford Foundation properties. Forest was particularly helpful during the County’s Zoning Ordinance Rewrite process, providing advice to his fellow board members on how best to voice the Foundation’s concerns about the impacts of the zoning ordinance on the preservation and use of historic Waterford properties. Forest also assisted the Board in connecting with County staff and members of the Board of Supervisors to keep them informed and seek their support in preserving the Landmark. We greatly appreciate Forest’s contributions as a member of the Board of Directors, and we look forward to his continued counsel and support in the future.

President's Report



The Foundation Board of Directors had a very productive year. The primary focus of the year's work was developing a comprehensive five-year strategic plan. Work in the first part of the Board's year focused on organizational hygiene, updating role descriptions for Board and Committee members, reviewing all policies and procedures and bringing them up to date, identifying areas of need in the areas of our Committees' charges, funding long-deferred property maintenance, and focusing on the financial health of the Foundation.

Committees have been reorganized for efficiency and to better align with the Foundation's strategic goals and needs and we have been actively recruiting new Committee members to support the many initiatives each Committee undertakes. We are continuing our shift to having Committees research issues and make recommendations and having professional staff oversee any actions, work, or projects. This is critical due to a need for consistency and centralization of work. The Archives Sub-Committee is now a part of the Education Committee and the three other Preservation Sub-Committees have now been narrowed to two Sub-Committees: Open Spaces and Historic Properties and Land Use.

The Board worked with staff to ensure that deferred maintenance projects were funded. Repairs and painting for the Red Barn, Bond Street Barn, and Old School were completed. New HVAC was installed in the Old School and Chair Factory. New stairs were added at the Mill and Chair Factory.

As a part of our focus on the financial health of the Foundation, we updated the membership fees and benefits associated with membership. We also voted to increase the fees for Fair tickets beginning this October. With the budget surplus from 2021, we initiated a reserve fund. All Foundation leases were updated and reviewed and rates brought to market rate, as needed. A new tenant was found for the Chair Factory upper floor. A comprehensive plan for grant seeking was developed and we applied for five grants.

The Foundation continued in its strategic partnership with the Waterford Citizen's Association to support the work of the 2033 Committee and its work on infrastructure improvements. Progress was made in bringing community water to the village. Currently, of the Foundation's thirteen properties, two have potable water, two have non-potable water, and the other properties have no water. Community water would increase the usability of these properties substantially.

The Foundation also continued in its partnership with Loudoun County Public Schools. Their curriculum specialist asked that we update our Second Street School program to comply with current standards. Their guidelines recommend that role-playing activities not be a part of discussions related to race and segregation and we updated the curriculum accordingly. Very few changes were made to the program and I am happy to report that students and teachers continue to fully enjoy a day in a one-room, African American schoolhouse in 1880. LCPS also asked that we work with them to create a new program on Reconstruction for seventh grade students. We are actively working on that project and hope to roll it out in a test pilot this coming fall.

Overall, it was a busy and successful year for the Foundation. We have great plans for the 2023 – 2024 Board session.

Executive Director's Report

In 2022 we worked to continue to stabilize the Foundation's financial health by growing our fundraising events and income from programs. Our two primary fundraising events, the Historic Waterford Trail Run and the Feast With Friends dinner series, both saw growth in 2022. The Trail Run reached 67 additional participants and raised over \$20,000 thanks in no small part to over 31 sponsoring businesses. The Feast With Friends dinner series was expanded to 5 dinners, serving a total of 172 attendees who together helped us raise over \$15,000 in support of our mission.



On the programming side, we continued to strengthen our three signature educational outreach programs: The Waterford Fair, the Waterford Craft School, and the Second Street School Living History Program. The 77th Waterford Fair was a major success including a great variety of artisans, craftspersons, entertainers, and merchants, with ticket sales increased by \$15,000 over 2021 figures as well as a significant increase in consignment sales.

The Waterford Craft School offered 17 new classes and served 158 participants in 12 successful classes throughout the year with students making baskets, miniature copper weathervanes, a dry stone fence, brooms, and more. Two summer camps served a total of 22 children learning about fiber arts and survival skills. Talks and demonstrations at the Waterford Fair served 69 attendees in 4 talks covering perfume making, pine needle basketry, block printing, and gunsmithing.

The Second Street School program hosted 25 classes last spring and 4 in the fall. We worked with LCPS social studies curriculum specialists to modernize the curriculum and bring it into alignment with the school system's guidelines for role play. We are continuing to work with LCPS on the development of a new field trip program for 7th grade students that will explore Waterford's experience during Reconstruction and into the early 20th century.

Through careful management, we maintained positive cash flow throughout 2022 and developed a budget for 2023 that prioritizes fiscal responsibility while working to expand our impact. Restructured membership fees and member benefits are bringing in additional funds while clarifying the philanthropic intent of our supporters. Multiple grant applications have been submitted with additional applications in the works. The new Landmark Suite at the Old School is used regularly for meetings as well as during special event rentals. Our staff are working closely with Loudoun County on the Mill stabilization project with an anticipated substantial completion date at the end of July.

To accommodate our current and future growth, we are in the process of implementing some staffing changes. Education Associate Lisa Kovatch resigned in March 2023 after several years of dedicated service beginning as the Fair Assistant before taking on the role of overseeing the Waterford Craft School. Upon Lisa's departure, Tracy Kirkman was promoted to Public Programming Director, overseeing Waterford Fair and Waterford Craft School. She will be supported by a new part-time Public Programming Assistant that combines the responsibilities of the former Education Associate and Fair Assistant positions. In addition to these changes, we plan to hire a full-time preservation staff person later this year to oversee our preservation programs. I am looking forward to bringing new talent to the office to help us meet our goals this year and into the future.
